OIA MEMBER PROFILE

This month we are profiling one of the founding Members of the Ohio Investigators Association, Rex Waldenmyer. Rex helped to develop OIA with the assistance of Rick Bearor and Larry Phillips in 1992 and went on to become the first OIA President. "When we first started our meetings we did not have any officers, so we managed the organization ourselves. The whole concept of the organization was to bring investigators from various state and local enforcement agencies together to share information." Rex helped develop training sessions for the members and started the practice of having quest speakers at the luncheons. He also brought in legal counsel, Mike Moran, to assist in registering the OIA name with the State and other legal matters. Rex saw the organization grow to 85 members in the first two years.

Before moving to Ohio, Rex served as a Pennsylvania Constable from 1976 until 1980. Rex is currently a lieutenant, handling all crime scene and internal investigations for Minerva Park. He has also worked for the State as an investigator for 14 years at the Bureau of Workers' Compensation and his current stint at the State Chiropractic Board. Rex is married with two children and two stepchildren.

AGENCY PROFILE

Agency: Office of Attorney General, Medicaid Fraud Control Unit (MFCU)

The Medicaid Fraud Control Unit (MFCU) was created in 1978 and is located within the Health Care Fraud Section of the Ohio Attorney General's Office. The unit is seventy-five percent federally funded and is responsible for the investigation and prosecution of health care providers who defraud the state's Medicaid program. In addition, this unit investigates allegations of patient abuse and neglect, which occurs within Ohio long-term care facilities and assists county prosecutors in the prosecution of abuse cases.

The MFCU work is complaint driven in that we receive over 600 allegations annually from the public, patients, providers, agencies, and law enforcement. We partner with other law enforcement agencies, the Ohio Health Care Fraud Task Force, county prosecutors, the Ohio Department of Health, the Ohio Department of Job and Family Services, and others in investigating and prosecuting cases.

Some recent investigations have lead to individuals being charged with Medicaid fraud, theft, tampering with evidence, forgery, fraud against private insurers, patient abuse, felonious assault, rape, gross sexual imposition, and kidnapping.
